4.1 Applications for consideration.

CH/15/0466 (BUDS ROAD) – Conversion of Barn into 3 Bedroom Dwelling and associated works. – **Objection: Does not comply with Local Plan and is outside the development area. Building on Green Belt land, which has been already objected to by AONB. (Site visit requested by Planning Committee)**

CH/15/0462 (LAND ADJ TO 11 BRADWELL LANE) – Amendment to change from a 3-bedroom dwelling to a 4-bedroom dwelling. – **Objection: Sufficient off road parking for three cars needs to be available due to impact to on-road parking, loss of visual amenity to houses immediately surrounding the proposed property.**

CH/15/0467 (LAND ADJ TO HOLLY HILL ROAD) – Removal of condition that horses using stable block and land may only be owned by applicant. – **No Objection – Concerns: Owners need to provide sufficient parking provision for multiple vehicles off-road so as not to impact on traffic.**

CH/15/0482 (PARKSIDE FARM) – Application for a ménage to ride horses. – **No Objection**

CH/15/0487 (THE RAG PUB) – Application for a change of use from cycle shed/shop to Microbrewery. – **No Objection**

CH/15/0484 (COURT HAYES FARM) – Retrospective application for buildings/land and ménage. – **Objection – Recommendation: Site visit requested from planning committee due to waste management and environmental issues. No change of land use requested before ménage erected, concerns over road access to property.**

CH/15/009 (PARK GATE) – Application to retain Marquee to the side of building. – **No Objection**
