The second appeal was from Ms Emma Beaman who had been working with the Scout Camp on a historical project, producing an audio trail around Castle Ring, Beaudesert, the walled gardens and the ruin of the old Hall.

Cllr's discussed both applications and decided to make a grant of £350 toward the Village Fayre and £100 toward the historical project on Beaudesert.

## **11. Road Safety within the Village.**

Cllr Healey reported that the Grit Bins had been refilled.

Cllr Healey reported that he had noticed that large potholes had appeared in some Village roads following the snow over winter. The carriageway in Cumberledge Hill, where the repair work to the Culvert had taken place was also subsiding. It was agreed the clerk should email Highways at Staffs C. C. about the issues.

Cllr's also expressed concerns about the level of street lighting in Holly Hill Road to the junction with Park Gate Road. They suggested they should ask for it to be assessed to see if it met current standards. The Clerk agreed to ask for an assessment of the lighting when emailing Highways at Staffs C. C.

Cllr Powis had received a complaint about an overgrown hedge in Hayfield Hill. The hedge, which completely obscured the bus stop, also encroached on to the footpath.

Cllr's discussed the problem and asked the Clerk to write to Arriva pointing out the problem with the bus stop being hidden.
